Sound Processor Upgrades / Replacements do not require admission to hospital and fall outside of the benefit for implantation of hearing devices.

Replacements / upgrades will usually require pre-approval based on a clinical reason or evidence that a device is no longer working, is not repairable, and is out of warranty. Processors are not usually routinely replaced either because they are out of warranty or because newer products have become available.

The process for securing health fund cover for replacement or upgrades is as follows:

- 1. Contact AHM by email info@ahm.com.au or phone 134246 or 1300 309 438 to confirm eligibility for replacement/upgrade.
- 2. AHM will consider eligibility only where medically necessary, current processor is out of warranty, 3 years from cochlear implant fitting and 2 years from bone anchored device fitting.
- 3. Download the AHM speech processor replacement form available at https://ahm.com.au/forms-guides
 The form must be completed by a medical practitioner.
- 4. Obtain written approval from AHM (email or by mail).
- 5. Send written approval from AHM and order form to the supplier.
- 6. Supplier will process the order and invoice the health fund.
